Kristjan Fjeldsted Anderson

NWMP/RNWMP/RCMP, Regimental # 2353/O.185



Kristjan Fjeldsted Anderson was born May 22, 1866 on a certain farm bordering the Huita River in Iceland. His parents were Andres Andresson Fjeldsted and Sesselja Kiristjansdottir. Not much is known of his early years in Iceland. However, we do know he left at an early age (disappeared actually) on a trip to Liverpool with a load of horses. It has been speculated that he was escaping an arranged marriage. The family in Iceland didn't know what had happened to him until the 1970's when his brother went to Iceland to trace the family.

Kristjan spent his first years in Canada at a number of jobs. Five years later he became a naturalized British subject. In 1889 he signed up with the North West Mounted Police. He remained a Mountie for 32 years retiring with the rank of Inspector (O.185).


His first post was Regina, then Maple Creek and finally Northern Alberta, the Peace River Country where he was the law. As a sergeant, he served in Fort Saskatchewan where he had numerous adventures. He often went on patrols, enduring many hardships including but not limited to the extreme weather conditions found in the Rockies and the route to the Peace River country. He gained a reputation as a relentless tracker with a stubborn streak (how Icelandic) and an iron constitution. On one occasion he chased a wanted man deep into the mountains during a blinding snowstorm eventually wearing him down and returning him and another accomplice to justice. During this time, he also played a role in the signing of Treaty 8 between the Crown and the local natives.

In 1904 the title Royal was added to the NWMP making it the RNWMP and in 1905 Alberta was created and the RNWMP was then stationed at Lesser Slave Lake. It was at this time the King Case occurred. Although the case seems to have officially started when a local chief brought



Anderson's attention. It is the family's understanding that it started when the brother of Edward Hayward, the murder victim, contacted Anderson by post from England. He had experienced a most vivid dream in which he witnessed his brother's murder. Apparently, he was so convincing that Anderson looked further into the circumstances. He learned that Hayward had been partnered with another man, Charles King, and they had been camping by the banks of Lesser Slave Lake. The Indians informed him that King had departed alone and Hayward's dog refused to leave the area. Further investigation led to the draining of a swamp, at Kristjan's expense, with the discovery of enough evidence to charge Charles King. He was convicted of the murder and hanged in Edmonton in 1905.

Hayward's brother claimed he saw King in his dream. Although this was not evidence, it did add a surrealistic element to the case. There is no historical evidence that draining the swamp produced a body although the family story says there was a body, badly decomposed. The story goes that in order to produce a corpus delicti Anderson removed the head as evidence. The story goes on to say that it was contained in a travelling bag in possession of him while on route to Edmonton for the trial when a well-meaning porter grabbed the bag, which came open allowing the head to roll out onto the platform.



Two heads cut off? Perhaps myth became legend! Barbara Crawford in her book "The First Post, A History of the Police Force in Peace River 1898-1998" tells of an

incident in which during the winter a man was murdered in Pouce Coupe, British Columbia. Anderson investigated. To do so, he trekked through winter conditions to retrieve the body, which by the time he arrived was frozen solid. Because it would be too difficult to transport the body in one frozen piece and because the injuries sustained were to the head, his solution was to remove the victim's head. He "packed it in a bucket with straw and took it with him to ship it to Edmonton for further investigation."

12655)). Both became members of the RCMP and retired as Staff Sergeants. A daughter, Dorothy, was born in 1919 in Fort Fitzgerald.

In 1915 he was promoted to the rank of Inspector and they moved to Grouard, in the Peace country. From there he conducted police business and had many more adventures. He was an outdoor man and spent time camping and trekking whenever he could. He also enjoyed playing mail chess.

Shena Meadowcroft in her book "Keeping the Peace" says, "the case will be remembered in northern Alberta for a long time to come, as the gruesome story of the sawed-off head in the bucket."

While his granddaughter was working in Montreal during the late 70's she went for a drink with one of the older engineers on a project she was working on. It turned out he had grown up in the Peace and knew her grandfather well. He said he had been chased many times as a young lad by her grandfather but that he was always kind and fair to him. This is a good epitaph along with her cousin's story of a visit to the home of the chief of the Sucker Creek Indian reserve around 1980 where he discovered a framed picture of their grandfather hanging in a place of honour on the wall, high praise indeed.



Delivering the mail, investigating the occasional murder, always getting his man and generally keeping the peace kept this member of the Force busy.

Some of that activity involved liquor, bootlegging and consumption. It was a major problem. According to Meadowcroft, Anderson was the bane of a bootlegger's existence. One story close to home involves a Peace River legend "Baldy Red". Anderson confiscated the offender's boatload of liquor and poured it over an embankment into the river. So, he thought. What Anderson didn't know was the bootlegger, the rascal and well-known character, had hidden underneath the overhang with a bathtub to catch the potent libation. Another trip through a still and it was fit to be drunk.

January 1, 1921, a severe hearing problem forced then 54-year-old Inspector Anderson to seek early retirement. The Andersons continued to live in Peace River for another 21 years, involving themselves, as before, in town life.

In Edmonton on March 22, 1935, the Earl of Beesborough, the Governor General of Canada decorated Anderson and 21 other former and present members of the Force at the Prince of Wales Armoury.

Many of Anderson's anecdotes found their way into the history of the NWMP, the RCMP and Peace River history over almost 32 years, as he rose through the ranks and served.

Kristjan met a young lady missionary named Leli Alberta Halpenny while he was stationed at Lesser Slave Lake and they married in 1905 after a lot of rowing back and forth across the lake. They had a daughter who was christened Peace (Margaret Cecilia Peace) as an acknowledgement that she was the first white baby born in the Peace River area.

They moved to Peace River in 1906 where he took up the position of the only law officer for the entire area for seven years. He was joined in 1913 by a constable. They had two sons born in 1908 (Charles Andrew Fledsted - Reg # 12045) and 1912 (Frederick Norman Fjelsted - Reg

In the fall of 1942, the Andersons, feeling the pinch of the increased cost of living and an inadequate pension, moved to Jasper to be with their daughter, Peace, and her husband Bert Robinson. A granddaughter recalls early memories of Jasper which include her grandmother feeding every form of bird and animal that existed, including the bears. Seven years later, January 8, 1949, Kristjan Fjeldsted Anderson, born Kristjan Fjeldsted Andresson, died. He was 82. He is buried in an unmarked grave in the Jasper cemetery.

The RCMP Quarterly of July 1949, Vol. 15-No.1, (76-77) in its tribute to his widow, daughter and two sons says, "his life exemplified the hope, trust and mutual benefits interchanged between state and immigrant in this country. His deeds are, indeed, his monument."
