The overall atmosphere was very congenial and there was a sense of esprit de corps. The ballroom was decorated in a Christmas motif, complete with Christmas trees, poinsettias, etc. The buffet dinner featured a Chef-carved Baron-of-Beef, along with chicken, fish, vegetables, condiments, and salads, as well as a variety of fruits and desserts, tea and coffee.

"Peacekeeping & Foreign Service" was the theme for this Levee with a number of those RCMP members who served overseas in attendance (see attached photos). We are pleased that the Commanding Officer, "E" Division, D/Commissioner Brenda Butterworth-Carr, and S/S Major Mike Procyck, along with other serving officers and members were in attendance. We invited spouses/ partners to attend this event, because many were also included in overseas postings, and in some cases, acted as "the second man." She installed D/Commissioner Butterworth-Carr as Honourary President; and RCMP Chaplain Jim Turner was sworn in as Chaplain for the Vancouver Division RCMP Veterans' Association, replacing Padre, Frank McLeod, who recently retired from this position. With the theme of "Peacekeeping & Overseas Service," we asked those attending, who served overseas, to place a marker on a large world map, showing their various areas of service. The decorations on each of the 10 dinner tables included a holder containing Canadian and NATO flags. Numerous items collected by these "Overseas" veterans were on display on side tables for



viewing, including passports, kits, photographs, memorabilia, etc., along with items displaying some of the Vancouver Veterans' Association's yearly events. RCMP Veteran, Laird Allan, with the assistance of RCMP "Overseas" Veteran, Arnie Atkin (who recently moved to Penticton, B.C.), compiled a continuous video presentation showing these Veterans, their locations around the world, their duties and work conditions, their fellow compatriots, environments/living conditions, etc. At the end of the evening, numerous gift items were raffled off to those in attendance, and it was noted that, through the courtesy of the "Hazelmere" staff, many guests stayed to visit after the main event ended at 8:30 p.m.

President's Report

From Your Division President.....

I would like to wish everyone a very Happy New Year and sincerely hope that 2018 will be filled with much health and happiness for you and your loved ones.

The first executive meeting for 2018 was held on January 5th. Many ongoing topics were discussed including the future of Fairmont Barracks situated on the Heather Lands in Vancouver.

V/Pres. Bob Underhill and myself attended a dialogue hosted by the City of Vancouver Planning Department on December 15th, 2017. A summary of that dialogue is included in this report. Unfortunately, when the Federal Government handed the land back to the Musqueam/Squamish/Tsleil-Waututh Nations, no notations were made as to the future of the historic Fairmont Building. Now that the First Nations have full ownership of the lands, the Chiefs are adamant that the building will not remain on their lands. Further information will be forthcoming from the City, but it certainly appears that a decision may already have been decided as to the future of the building. Note that the recommended concept for the Heather lands will be forwarded to City Council by early Spring with a final decision to be made by early Summer. If you have any questions or would like to participate in future dialogues with the City, please advise.

The Division Executive are still seeking members who would be willing to serve in an executive positive for a two-year term. Job Descriptions have been rewritten and were presented to the Executive on January 5th. All were approved and will in presented to the membership at the February 15th, General Membership Meeting.

Members are still being sought to fill the following Executive positions:

- **Director Communications** (currently being covered on an interim basis by Eric Ross, Director Strategic Planning)
- **Director Membership** (currently being covered on an interim basis by Ric Hall, Liaison to the Force)
- Secretary (Mert Rowden has agreed to continue in the role until a replacement steps forward)

 Director Health, Welfare and Advocacy (currently being covered on an interim basis by Ron Budd)

Liaison to the NCO's Mess – Presidential Appointment (vacant)

As you are aware, for the past few years the Division has had a yearly theme which culminates at our Levy. It has been 30 years since the Bruce Denniston Bone Marrow Society was established and I am very pleased that your Division will be honoring this worthwhile cause during 2018. Cst. Bruce Denniston, Reg #30106, was diagnosed with leukemia in 1987 while stationed at Powell River Detachment. The Unrelated Bone Marrow Donor Registry, now known as One Match, had very few registered donors in 1987 but the community of Powell River and Bruce's RCMP colleagues rallied to the cause and the word spread for the need for donors, not only for Bruce but for other patients in similar circumstances.

This was the beginning of the Bruce Denniston Bone Marrow Society and over the past 29 years the Society has continued to raise money to help the Registry find donor matches as quickly as possible. It also provides volunteer couriers, mostly retired RCMP members, who travel to hospitals around the world to bring back lifesaving bone marrow and stem cells for patients. In fact, there are several of our Vancouver Division members who volunteer their time for this worthy cause.

It is shaping up to be another busy year for the Division and any assistance our members can provide to the Executive and the Division would be appreciated.

Please get involved - after all, this is YOUR Division.

Business Meeting

- **Resumption of Meeting -** The meeting was called to order by President Morse at 1:00 p.m. with thanks being given to Hazelmere Golf Club staff for preparation of the meal.
- Celebration of Life President Morse noted that a Celebration of Life will be held on November 16, 2017 in honor of Cst. John Davidson. All members are invited to attend (including Vets) and that transportation may be arranged from E Division. Gordon Cave is the contact person. There will be live television coverage beginning at 11:00 a.m.
- **2017 Levee** The Levee will be held on Friday, December 8, 2017 at Hazelmere Golf & Country Club. The theme will be 'Foreign Service of RCMP Members'. Dorothy Martinson requested that any member that had served in the RCMP Foreign Service and has memorabilia, that could be displayed on tables, to please contact her.
- Job Descriptions President Morse noted that at least four positions on the Executive were vacant and that some of the current Executive are having to do double duty. Past President and Nominations Committee Chairman Keith Leishman described the outstanding positions and that he had been unable to find members that were willing to take on these jobs. He called for volunteers from the floor for these positions, however, there were none. He noted that failure to fill these positions may mean that we have to cut back on some of the services that the Vancouver Division provides.
- **Fairmont Barracks** President Morse noted that an article had appeared on CBC on October 28, 2017 concerning the future use of the RCMP Fairmont Barracks at 33rd & Heather St., Vancouver, BC. Dick Hawkshaw noted he was a member of a committee with senior officers several years ago with the idea of making the location a retirement home for veterans. A BC Society had also been formed. A lack of concrete action was primarily due to the cost of renovations and the lack of funds to complete the project. After several meetings, with little or no progress, the Society was allowed to expire.
- **New Members** Only one new member was in attendance Bob Pinkewycz, Reg. No. 37305. President Morse and Membership Chairman Ric Hall performed the swearing in.
- **Health & Welfare** Ron Budd reported that there appear to be homeless members but does not have any statistics at this time.
- **Treasurer's Report** Rupert Bullock reported that there is approximately \$12,000 in the Association's bank account, money is coming in for the Levee (\$50/person) as well as 2018 membership dues (\$65/person). The audit for 2015 should have been completed by the end of October but there has been no report yet. The audit for 2016 presumably is underway but we've had no report.
- **50/50 Draw** The draw was won by Keith Leishman who received \$95. Meeting was adjourned at 1:52 p.m.

NOTE: The Fairmont Building was not depicted in the three pictorial concepts of the Heather/Fairmont Lands which were on display at this meeting. When the question was posed to the City, Bob and I were informed that two of the concepts could go ahead with the Fairmont Building remaining intact.

Background:

In 2011, Canada Lands Company (CLC) formed a partnership of the Musqueam Indian Band, Squamish Nation and Tsleil-Waututh Nation (collectively the MST Partners) to redevelop the Heather Lands which are owned by MST. The City, at the request of the CLC and the MST Partners, have been working collaboratively, since 2016, with the landowners and the local community to develop a policy statement to guide the future development of the 21 acre Heather Lands site.

The launch of discussion regarding the lands commenced in July 2016 with the principles and concepts presented in November 2017. The three pictorial concepts, mentioned above, were part of this presentation.

The plan is to have the preferred concept presented to community and council in spring 2018 with a final decision in early summer 2018.

Dialogue Overview:

The dialogue started with Chief Ian Campbell addressing the group. Chief Campbell was very passionate regarding his belief for the need of reconciliation for the three nations. He spoke of the long history of Fairmont, the RCMP and the negative impact that history has on the MST First Nations people.

CLC is supporting the removal of the building for reconciliation and transform the land to a cultural centre.

MST Development Corp spoke how the Fairmont building is a symbol of colonization. While MST is not outwardly stating the building should be torn down, Chief Campbell is emphatic the MST nations will not pay any costs associated to the upkeep/retention of Fairmont. If a third party is found, with the funding available to move the building to another site, this would be acceptable to MST Development, CLC and the City.

The RPSC group are not in favour of the removal of the Fairmont building from Heather Lands. It appeared that RPSC was, also, not involved in the initial planning process.

Most of the afternoon was spent in group discussions. Unfortunately, Chief Ian Campbell did not stay as he had another engagement. While the Chief was leaving I did approach the Chief requesting an opportunity to speak with him, at some later date, but it is unknown whether this will occur. A report will be submitted by the consulting group overseeing the afternoon activities which will be forwarded to our membership when received.

I have now been in contact with Cpl. Angela Kermer, RCMP Aboriginal Policing Services. Cpl Kermer was very supportive of the Division's stance regarding the continuation of Fairmont Barracks as a heritage property. She will be escalating this issue up the chain of command and will further advise.
