SECRETARY'S MESSAGE:

It was an absolute BLAST connecting with the Members and their spouses and I still have fond memories of the Bus trip to and from Penticton.

In 2019, I took on the role as Organizer of the RCMP Vets AGM, which was to take place in Vancouver in May 2021. Due to Covid Restrictions, this event was Canceled. Prior to its cancelation, I dealt at length with the Vancouver Vets Executive and the Sheraton Guildford as a venue for the AGM, social gatherings, Banquet and accommodation for our Delegates.

HISTORY OF THE RCMP VETERANS ASSOCIATION SILHOUETTE

The silhouette the member used by the RCMP Veterans' Association and is retired Supt John BILINSKI. It was taken on November 11, 1977 at the Ottawa Cenotaph. John had illustrious career and is now living the life of a happy retired member in Ottawa.

John recalls "the weather on that day was unbearable cold. Once the ceremony ended, I remember looking up and seeing my mother who was a WWII refugee survivor, standing there with tears running down her cheeks. She is gone now, but the memory still affects me greatly".



DIRECTOR OF HEALTH & WELFARE – ADVOCACY:

I had a number of Vets contact me regarding assistance with medical claims, and follow up on their pensions. In January, I dealt with 11 Assistance files with retired members and their families, 3 still remain open for additional enquiries and follow up.

The recent National Bulletin regarding the absence of the COLA clause on Medical pensions, and the proposed catch up naturally raised a number of enquires that were resolved.

I have recently developed a number of contacts that I can now deal with direct, as a number of employees both RCMP Pension Division and the Veterans Affairs Branch are working from home, and undoubtably a number of phone calls go directly to voice mail at these branches. A lot of the staff with these agencies are going the extra mile to assist during these difficult times.

Ruby BURNS, the National Advocacy Director has stepped down. She has done an excellent job and her shoes will be hard to fill. Mike Duffy from Lethbridge RCMP Vets has been named as her replacement. Mike recently completed a revision of the Advocates Manual, bringing it up to date for 2021. The manual has been retitled 'Guide to Health Benefits Services 2020" and is available on the Association website: https://rcmpva.org/advocates-en/

HONOUR HOUSE - A PLACE FOR THOSE IN NEED



Honour House is a refuge, a "home away from home" for members of our Canadian Armed Forces, Veterans, Emergency Services Personnel and their families to stay, completely free of charge, while they are receiving medical care and treatment in the Metro Vancouver area. These brave individuals, along with their families, sacrifice so much on a daily basis to protect our freedom and our everyday way of life. Honour House allows us the opportunity to show them that we care and

how much we appreciate all that they do for us.

Through this Pandemic, Honour House has remained open to those who need to travel to Vancouver for Medical treatment, and is occupied more often than you could imagine. Since opening in 2010, Honour House has provided more than 10,000 nights of free accommodation. Dedicated volunteers have continued to clean the Rooms, tend to the Grounds and offer financial support. Honour House has a reputation for being a Safe Haven for those First Responders in need, which include our RCMP Family (both Serving and Retired members).

Honour Ranch – Psychological Support

Honour House Society's second major project, <u>"Honour Ranch",</u> is based just outside of the village of Ashcroft, BC. The ranch provides support and a place of solace and calm for those dealing with the debilitating effects of Operational Stress Injuries. Ten private cottages and one spacious lodge sit on a beautifully secluded and peaceful 120 acres, amongst old growth forest, overlooking the South Thompson River Valley, which held its official opening on October 5, 2019.

Volunteers continue to invest their time and dedication to travel from the Vancouver area to Honour Ranch to renovate and repair the site, and update each Cottage and the Main Lodge in preparation for those First Responders in need.

RCMP ANNUAL PENSIONER'S STATEMENT



By now, most members should have received their RCMP Annual Pensioner's Statement from Public Service and Procurement Canada. After reviewing the document, one of our members writes:

"I was reviewing my recently received statement and make the following observation. On page 5 they outline the Public Service Health Care Plan. We have the opportunity to select Level 1,2 or 3 and this is associated to maximum hospital benefits. For many years I had selected and paid for level 3. I wondered what the difference was as our experience with hospital

stays is that you are placed in a ward and room based upon your health need. In other words, a level 3 does not ensure you have your own room, at least not in B.C.

I called the number provided, 1-855-502-7090 and confirmed the following. The deductions we have under PSHCP provides coverage on prescriptions, which for me is important with the normal reimbursement of 80%. That coverage is provided whether you pay for Level 1,2, or 3. I wonder how many members are choosing level 2 o 3 thinking they are receiving better coverage?

In B.C. it really is only necessary to pay for the level 1 coverage, we have no say in what hospital room one will be placed. Hope this makes sense. Some Vets' may be able to save a bit of money. In my personal case I am deducted \$122.05 (one dependent) for level 1, but would be paying \$151.42 if I chose level 3."

To check your coverage level, check your most recent pension pay statement (Pay stub).

ALBERTA EMERGENCY SERVICES MEDAL:



It has been brought to our attention that some of our members who may have served in Alberta ("K" Division) may qualify for the Alberta Emergency Services Medal. The Alberta Emergency Services Medal (AESM) honours emergency services personnel who are involved in supporting emergency prevention, preparedness and response in Alberta, and who have committed 12, 22, 32, 40 years of service. To be eligible for the medal, personnel must have been serving on or after **January 1, 2000**, in a sector of the Alberta emergency management system. FEBRUARY 2021 - FAIRMONT BARRACKS/LANDS UPDATE.



As many of you are aware. Fairmont Barracks surrounding lands and the are being redeveloped. Since 2017, and on behalf of Vancouver Division Veterans, I have been in discussion with the City of Vancouver regarding the redevelopment plans for the Fairmont building and the need to protect this historical site. In the past couple of weeks, I have spoken with a City Planner who is overseeing the development and was pleased to hear that the City is still looking into the possibility of moving the Building.

Canadian Development Corporation (CDC) have offices within the Fairmont Building and both CDC representatives, and City officials, are aware of our concerns with the building. They are also aware there are the buried remains of one of our own under the flagpole in front of Fairmont. Last year, in speaking with an archeological company completing an archeological assessment of the lands, I was informed there was a good possibility that the urn that was buried could still be intact and recovered.

Further to this, some of you may recall that a request was sent out last year for stories to be submitted relating to memories of Fairmont Barracks. I am pleased to advise that over twenty stories were received and will be published in a book "Memories of Fairmont Barracks". I would like to thank the RCMP Heritage Centre for supporting the publishing of this book and all that entails. Also, a thank you to "E" Division NCO's Mess for their donation towards any copyright fees that will be necessary for including several historical news articles and photos in the book.

Updates will be provided as received from the City. Also, stay tuned for the 2021 release of "Memories of Fairmont Barracks".

VETERANS DISABILITY PENSION INDEXING ERROR CLASS ACTION:



Dear Members of the Association,

Jan and Vic Gorman of Nova Scotia Division have provided a link to a public announcement by the law firm Murphy Battista of British Columbia that they are launching a class action lawsuit (Manuge v. Her Majesty The Queen: Federal Court: T-119-19)

From the Notification,

"Murphy Battista LLP has filed a proposed class action against the Government of Canada concerning an error that was made in the calculation of Veterans Affairs Canada Disability Benefits payable for the period 2002 to 2010. The error was allegedly discovered by the Government in 2010, but not disclosed to veterans until 2017 as a result of a report by the Veterans Ombudsman. The Government of Canada has admitted there was an error and that \$165 million dollars is owed to the affected veterans. The Government of Canada has advised they will pay out the money in 2020 without interest."

The link to view the announcement follows. It is also noted that if you wish to receive information about the progress of the court process you may find out how to do it through the announcement.

VAC TREATMENT BENEFITS PROGRAM – COVID 19 SUPPLIES:

Chief Advocate Ruby Burns and Nova Scotia Division members, Vic and Jan Gorman have provided the following information regarding the availability of COVID-19 supplies to certain recipients of VAC benefits.

The information follows. Unfortunately, we do not have a French version of the order form referenced in the message and linked at the end of the message.

VAC Treatment Benefits Program – Covid 19 Supplies

During this National Covid 19 pandemic, VAC has made some temporary changes, including paying for masks and sanitizers if required for personal treatments and if the member/veteran is receiving a pension from VAC.

As for limits of supplies and applicability, the member/veteran should confirm with VAC (1-866-522-2122) before purchasing .

Personal Protective Equipment

Q; I need personal protective equipment to attend my health appointments. Will VAC pay?

A: Yes, you may be covered if you need to wear personal protective equipment such as nonmedical masks and/or gloves to receive treatment. Additionally, if you need an escort OR family member to attend your appointment VAC authorized treatment with you, their personal protective equipment will also be covered.

What type of personal protective equipment is covered?

VAC will reimburse the cost for personal protective equipment including non-medical masks and/or gloves, if your health professional requires you wear personal protective equipment. The current year is \$200.00/CY – Benefit Code 400935

How do I get reimbursed for personal protective equipment?

You can use your VAC Health Identification Card to purchase personal protective equipment. You can use this card with VAC registered health care providers such as your local pharmacy or treating health professional. They will bill VAC directly so you do not need to pay out of pocket.

If you are unable to use your VAC Health Identification Card, please complete a VAC 918 Client Reimbursement Claim Form and submit to Medavie Blue Cross by mail to:

You will need to submit your proof of payment (original receipt or invoice) that shows:

- the date you received the benefit or service;
- the name of the benefit or service;
- the amount you paid; and,
- the name and address of the provider.
