VANCOUVER DIVISION:

The Provincial Health Orders moved to Phase 3 of the Reopening Program for our Province in early July, with the hope of Phase 4 in early September. Unfortunately, this did not take place. Instead, we are well into the 4th wave of COVID. Due to increased COVID numbers, along with Hospitalization (including ICU), we have taken a step back (and more than one in many Regions)! Members living in our Eastern Valley areas are faced with limiting important personal connections, and returning to small bubbles once again.

During the summer, we are able to extend our social bubbles (bearing in mind our own personal boundaries and comfort zone), take part in more social activities and remove those masks (if we so choose). We could get together with friends and family members, who have been in our hearts (through Zoom, Facetime or just a simple phone call) for over a year. Most should be fully vaccinated (based on choice or your medical situation allow).

As of mid-September, the Vaccine Passport is now another "piece of paper" or "Photo on your Phone" that allows us to take part in Social Activities that make us feel human.

We were optimistic that our Association would be able to meet in person in September, however, this did not happen. The current Covid safety plan at Hazelmere would not have allowed us to hold the type of personal gathering that our members would like. With the Vaccine Passport and its guidelines at this point in time, it is not feasible to hold any large social gatherings. We will keep our membership updated. Accordingly, our first General Meeting, booked at <u>Hazelmere for</u> <u>Thursday, October 21st, has been cancelled</u>.

2021 COVID UPDATE: We are now into the second year and the 4th wave of the COVID pandemic. Due to rising numbers of COVID cases and Hospitalization, the much anticipated Phase 4 reopening did not take place. Life continues to change for each and every one of us. The Provincial Health Orders, currently in place, evolve daily it seems, on a Regional basis, which

precludes any "in person" gatherings of the Vancouver Vets for the foreseeable future. Social interactions that we, perhaps, took for granted have been difficult and our monthly gatherings seem like a distant memory. The Vaccination program has taken a toll on many of us, both those who are vaccinated and those not, but health authorities are optimistic that by the end of 2021 most of us who want the vaccine will have it. With that in mind, we are hopeful that our Association will be able to meet sometime before the end of this year.

VACCINE UPDATE:

The vaccination program has been ongoing for the past 9 months and we have offered assistance to those who have questions about booking and transportation to receive the Shot. With the ongoing and ever changing COVID situation, we encourage our members and their families to stay connected (in person, if able, and Virtually, if required). As the social bubbles expand, stay safe as you meet with friends and colleagues who have been phone buddies for the past 18 months. Please remember that your fellow members are there for a quick phone call, to catch up on friendships and future endeavours.

The RCMP on June 25th announced the appointment of Assistant Commissioner Dwayne McDonald as the next Commanding Officer of the RCMP in British Columbia and took over command from Deputy

Commissioner Jennifer Strachan on July 1st. No decisions have been made yet with respect to a formal change of command ceremony.

Deputy Commissioner McDonald's 26-year career in the RCMP started as a front-line officer with the Burnaby Detachment and includes serving as Officer in Charge (OIC) of the Surrey Detachment. He also served as OIC of the Integrated Homicide Investigation Team, a senior role with the Combined Forces Special Enforcement Unit and most recently as Criminal Operations Officer, Federal Investigative Services and Organized Crime.

D/Comm. Strachan retired after 33 years with the RCMP. She worked in multiple detachments, sections, Provinces and a peace keeping mission in Haiti. When she was named the Commanding Officer of the RCMP in BC, her 13th and now last physical relocation, brought her back home to BC where her policing career started.

TREASURER'S REPORT – DUES 2022

On September 22, 2021, Sandy Glen, National President, advised that effective January 1, 2022, the National portion of your dues will increase from \$37.00 to \$45.00. The Board of Directors of the Vancouver Division have not had the opportunity to meet to discuss whether or not to increase our annual dues, which currently are set at \$65.00 per annum.

DIRECTOR OF HEALTH & WELFARE - ADVOCACY:

I had a number of Vets contact me regarding assistance with medical claims, and follow up on their pensions. It has been a little quieter than previous months.

The recent National Bulletin regarding the absence of the COLA clause on Medical pensions, and the proposed catch up naturally raised a number of enquires that were resolved.

I have recently developed a number of contacts that I can now deal with direct, as a number of employees both RCMP Pension Division and the Veterans Affairs Branch are working from home, and undoubtably a number of phone calls go directly to voice mail at these branches. A lot of the staff with these agencies are going the extra mile to assist during these difficult times.

Mike DUFFY, the new National Advocacy Director Mike is a member of the Lethbridge RCMP Vets. Mike recently completed a revision of the Advocates Manual, bringing it up to date for 2021. The manual has been retitled 'Guide to Health Benefits Services 2020" and is available on the Association website.

Foundation To Expand Reach Beyond Helping Veterans Pay Legal Bills Bernise Carolino

"We must keep pushing for justice, and we want to hear from federal leaders on this need," said Stoffer in the statement. "But in the meantime, we'll do as much as we can to give veterans the front-end support they need now," he added.

The Veterans Legal Assistance Foundation is a charitable organization promoting access to justice for current or former members of the Canadian Armed Forces and the RCMP, as well as their family members, by lessening the burden of legal fees relating to administrative tribunals and courts. The foundation's funding originated from the <u>SISIP class action settlement</u>, aiming to assist veterans in acquiring the payments to which they are entitled.

Previously the foundation had been paying for veterans' eligible legal bills up to \$10,000, normally for disability and other claims broadly benefiting veterans. The foundation now expects to do more thanks to the new funding, said Peter Driscoll, founding chair of the foundation and lead counsel on the SISIP class action, in the news release.

"Veterans need help with forms and documents, especially if they are dealing with physical or mental health disabilities," said Dennis Manuge, VLAF ambassador and representative plaintiff for the SISIP class action. Sometimes veterans simply need assistance with using the Veterans Affairs Canada website and not with court proceedings, Manuge added.

The **Toth v. Canada** class action, which challenged the validity of offsets made by the federal government to the disability pension prior to May 29, 2012, <u>resulted in a \$100-million settlement</u> agreement, with unclaimed amounts being considered residual funds. On Jan. 6 the court determined that such residual funds would be paid to four charities: the Veterans Legal Assistance Foundation, the Bursary Fund (Manuge), the Royal Canadian Legion Poppy Fund and Ottawa Inner-City Veterans Outreach and Support.

As a valued member of the National Association of Federal Retirees, you have exclusive access to this MEDOC® Travel Insurance program. To have this MEDOC® coverage, you need to maintain your annual membership with the National Association of Federal Retirees. If both you and your spouse/partner have MEDOC®, you need a double membership with the National Association of Federal Retirees. If you are unsure of your membership status, please contact our national office toll free at 1-855-304-4700 or in Ottawa at 613-745-2559.

Travel and COVID:

As we approach the end of our 2nd Year under Covid Restrictions, we see may Countries open their borders to International Travelers. For those who are looking into getting out of town / Canada, questions arise about the process for Covid testing (PCR vs Antigen) both when you depart and return/plus the additional expense; if your Vaccine (or Mixture) is acceptable and the almighty, what if I get COVID during my travels.

Many insurance companies advertise that they offer "coverage for Covid-19", including medical expenses, and Emergency-related expenses: but **READ THE SMALL PRINT**. Ask questions that pertain to your own situation (what vaccine you have, where to get the Covid test both leaving and returning to Canada, the turnaround time for the test and the cost). We have all heard anecdotal stories both on mainstream media and social media.

Many of you are Snowbirds or just want to get away to the sun. Be sure to do your research. Many of us use MEDOC travel insurance, but some changes have been made to coverage and benefits. OLD MEN'S PROVINCIAL CEMETERY

The City of Kamloops incorporated in 1893. Just one year later, it became home to the Provincial Home for Old Men. The Home was built on the farm site belonging to former Government Agent Constable John Ussher who was killed by the Wild McLean Boys twenty years earlier. The Home was meant to house the old fur trappers, guides and gold miners who opened up the province during the early pioneer years.

The first resident arrived in May of 1895. The first recorded death occurred a year later and a special Home Cemetery was opened for the old men on the bench-land above the Provincial Home. The poor and indigent also shared this cemetery located on the outskirts of town. Most of the over 1,000 graves remain unmarked since Home administrators often had little background information about their old residents. There are written archival records showing the location and name of each burial. Some of the small flat stones which marked individual graves have gradually sunk and lie buried beneath the grass. The last person to be interred in the Old Men's cemetery died in 1974. By then, the famous old Home had been demolished and a new seniors residence built in its place.
